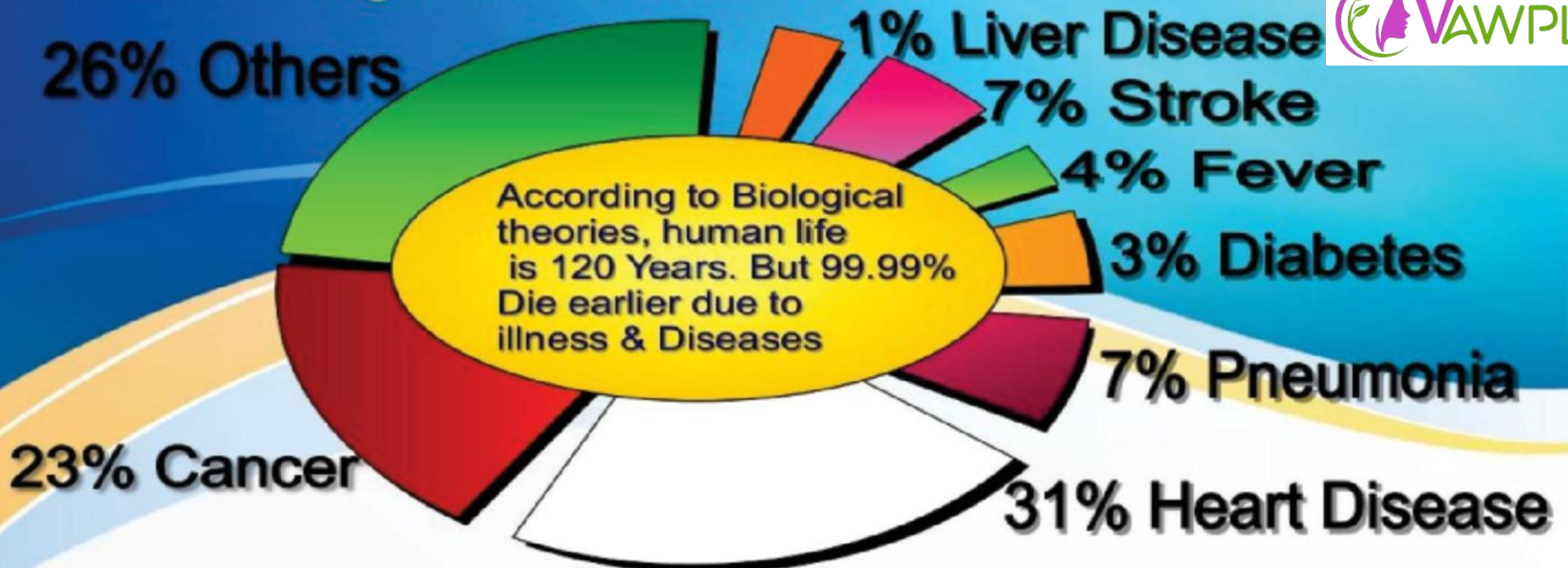

Environmental pollution threatens human health. Air pollution in cities causes a shorter lifespan for city dwellers



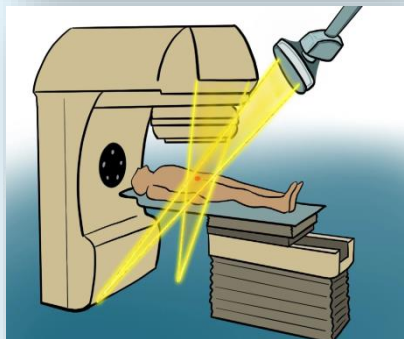
WATER POLLUTION
